Credential forms will be mailed in September and are to be returned to IWBA Office by **December 15**, 2004.

WIBC Credential forms are to be returned to WIBC by November 15, 2004.

All award forms for the 2003-04 bowling season are to be sent to the IWBA office by **September 1**, **2004**, including the summer leagues.

Bag Tag award forms should be forwarded as soon as received as this award is mailed directly to the bowler. Be sure that all information is included on all award forms.

High Score Awards for 275 and up; 675 and up should be forwarded as processed by the local association secretary.

Award forms for 100 pins over average should be forwarded as received by local association.

The following rule has been changed for the 2005 IWBA State Tournament in Belleville, IL:

RULE #14 – SUBSTITUTIONS WILL NOT BE PRO-VIDED BY THE ILLINOIS WBA NOR THE HOSTESS ASSOCIATION. A LISTING WILL BE AVAILABLE IN THE TOURNAMENT CITY FOR USE BY THE TEAM CAPTAINS. AN ENTRANT MAY BOWL ONLY ONCE IN EACH EVENT.

ALSO RULE #16 – NO UNREASONABLE DELAY IN THE PROGRESS OF ANY GAME SHALL BE PERMITTED. ANY MEMBER REFUSING TO PROCEED WITH THE GAME AFTER BEING DIRECTED TO DO SO BY A TOURNAMENT OFFICIAL SHALL RECEIVE ZERO FOR THOSE FRAMES MISSED AND SUCH GAMES OR SERIES MAY BE DECLARED FORFEITED.
