129TH ANNUAL ILLINOIS STATE USBC OPEN TOURNAMENT RULES

ENTRIES CLOSE MAY 3, ONE HOUR BEFORE 2ND SQUAD IF LANES ARE AVAILABLE

- No one under the age of 18 may bowl in this tournament. The prize list will be based on entries received on the handicap score, with a ratio of at least one prize for each six entries in the team, doubles, and singles events; and one prize for each ten entries in the All Events. Prize letters will only be sent to team captains receiving prize checks for entrants. The complete prize list will be posted on our website.
- 2. All entrants in this tournament must be members in good standing of the Illinois State USBC with a 2025-2026 USBC Certification Card. Any eligible non-member may purchase a Standard USBC Membership card. A bowler found not having a valid USBC Membership Card will forfeit all fees.
- 3. Handicap will be based on 90% of 230, of each bowler's highest USBC certified average for 21 or more games during the 2024-25 season, including 2025 summer leagues. A bowler with no qualifying average for the 2024-25 season will use the current USBC average for 21 or more games at the time of bowling the first event of the tournament. If not qualified via above, the bowler must bowl scratch using 230. A bowler will use their highest USBC Average or Converted Average.
- 4. Participation in the team event only: Not more than three (3) players on the same team can place more than once in the prize list. No more than two professionals (Card holder of regional, national or other national events). may compete in Team, only one in Doubles. In regular All Events, the first team appearance score is used. Singles/Doubles must bowl and pay for both events and can be bowled multiple times with change of partners and cash only once in singles,
- 5. All events, Scratch or Handicap, are not transferable unless the substitute replaces original entrant in all three events.
- 6. Optional Scratch Prize List: All events based on team doubles/singles; the prize ratio will be the same as the regular prize list.
- Substitutions are allowed if needed after entry blank is mailed. Substitutes will not be provided by the Illinois State USBC. Please
 arrive early so the tournament personnel can make the changes. Bowlers must bowl in order submitted on entry form.
- 8. Re-Rate and Reporting of \$300 or more prize money is the responsibility of each bowler that this applies to and they must send data with the entry form. Failure to comply could result in forfeit of tournament fees and prize winnings and a possible suspension.
- 9. Rule 319(A), excluding item 1); 319 (C) & 319 (D) will be applied. The ten (10) pin rule applies Rule 329 (Protest) will apply.
- 10. Averages will be shown on the recap sheets and it will be the responsibility of each bowler to verify the average shown. Any failure to use the proper average or make corrections prior to the completion of the first game of a series, shall be cause for disqualification of the score, if the submitted average is lower than the actual average; or the prize will be based on the submitted average if it is higher as it cannot be lowered.
- Lane dressing will be what each bowling center normally provides and in compliance with USBC rules. Lanes will be stripped and dressed for every squad.
- 12. Awards: Plaques are awarded to actual scratch winners in each event. (Optional scratch entry not required.) In addition, actual scratch All Events winner shall receive a paid entry for the 2026 USBC Masters tournament, upon their making a written request.
- 13. Bowlers are not permitted to smoke while participating in the Illinois State USBC Open Championship Tournament. This includes from the start of practice to the last ball rolled for score in each event. This also includes between doubles and singles event. Failure to comply shall result in immediate disqualification. NO ELECTRONIC SMOKING DEVICES TO BE USED DURING TOURNAMENT COMPETITION.
- 14. Bowlers need to be up and ready to bowl when it is their turn. A one lane courtesy will be observed.
- 15. The Tournament Manager has the authority to make decisions regarding anything not covered by these rules.
- 16. Proper attire is required, no profanity or gestures will be allowed.
- 17. TIME Constraint Team will be shut down after 3-1/2 hours, Doubles/Singles (4 on a pair) 4 hours and (6 on a pair) 5 hours.
- 18. All other USBC rules apply.
